

- In light table No: 1 M/S Friends Associates is the only Responsive bidder for Canteen Services of Main Campus at Charbagh and Shangla, and Being a single bidder having **\*single bid** for Multiple food items( comparison of Multiple items rates in like circumstances in not possible) shall not lead to a prudent decision with due diligence in light of KPPRA rule 14 A and section 3 of the KPPRA Act and shall make the procurement process ambiguous and shall lead to mis procurement and value for money could not be achieved in light of Kppra Act#3 & KPPRA Rule No: 2(g):
- Considering Table, No: 02 all the bidders are found nonresponsive for Photocopier Services of Main Camus Charbagh Swat and Shangla Campus and hence are disqualified
- Therefore, in the best interest of university the Committee Unanimously recommended **Retender** (of the Canteen and Photocopier Services) after subsequent approval of the Competent Authority for All the Campuses of the University.
