The University of Swat invites sealed proposals (Single Stage Two Envelope Procedure) in accordance with KPPRA/PPRA/PEC Rules and the Request for Proposal (RFP) from well-reputed Firms registered with PEC in Category C-3 and AEDB in Category C-1 for the “**PROCUREMENT OF AGGREGATE 500 KWP ROOFTOP ON-GRID SOLAR PV SYSTEM ON PPA BOT MODEL**” at Main Campus, University of Swat, Charbagh-Swat.

University of Swat may reject any or all proposals at any time prior to the acceptance of the proposal in accordance with KPPRA Rules.
