

MINUTES OF THE MEETING OF GOODS PROCUREMENT COMMITTEE, UNIVERSITY OF SWAT

The Convener GPC convened the meeting of the Goods Procurement Committee held at the Committee Room, Main Campus Charbagh, University of Swat on (Monday) i.e. December 08 2025, at 2:30 PM in Committee room of Administration Block University of Swat.

Agenda: Bids Opening Under Single Stage One Envelope Procedure for Package M: Boys Hostel Mess and Package H: Foods Huts for Academic Block A and Women Campus, University of Swat **Proceedings:**

- 1. The Convener welcomed all bidders and members of the Procurement Committee to the meeting.
- 2. After a brief introduction, the Convener invited the Secretary to present the agenda for the meeting. The Secretary proceeded to outline the procedure for opening and evaluating the bids.
- 3. The GPC (Goods Procurement Committee) met to open and evaluate the technical bids for the abovementioned packages under the single stage two envelope procedure. The following bidders were present:
 - a) M/S LALA KITCHEN
 - b) M/S MALAM JABBA CONSTRUCTION COMPANY
 - c) M/S KASHIF CONSTRUCTION COMPANY

Technical Evaluation Results

The bids were evaluated as per the given criteria in the bidding documents. The qualification score is 50%.

- a) M/S LALA KITCHEN:
 - i. Package M: Scored 86% marks
 - ii. Package H: Scored 86% marks

The firm has demonstrated substantial compliance with the technical requirements and is qualified for financial bid opening for both packages (Package M: Boys Hostel Mess and Package H: Foods Huts for Academic Block A and Women Campus).

b) M/S MALAM JABBA CONSTRUCTION COMPANY:

i. Applied for Package M only: Scored 45% marks

The firm's bid for Package M is deemed not responsive for financial opening as it fell short of the required qualification score of 50% and failed to meet specific mandatory requirements as stipulated in the bidding documents.

c) M/S KASHIF CONSTRUCTION COMPANY:

- i. Package M: Scored 8% marks
- ii. Package II: Scored 8% marks

The firm's scores for both Package M and Package H were significantly below the required qualification score of 50%, and it failed to meet the mandatory requirements, rendering its bids for both packages not responsive for financial opening.

4. Next Steps

The financial bids will be opened on December 22, 2025 (Monday) at 2:30 pm in the Committee Room, Admin Block, University of Swat.
