



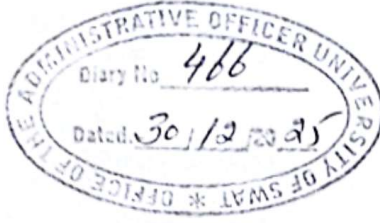

2. Recommendations and Decisions

Based strictly on the adherence to KPPRA rules regarding the lowest evaluated responsive bid for each line item (AS per CS at annexure A):

- **M/S Sunshine Enterprises** is recommended as the lowest bidder for item at Sr. No. 01 (4 tyres), with a recommended supply order amount of **PKR 166,500** (AS per CS at annexure A).
- Initially, 4 tyres were tendered for the Coaster (Sr. No 2). The Admin Officer later requested 2 extra tyres, and the committee agreed to increase the order to 6 tyres under Clause 7 of the BSD, which states: "the number of items can be increased or decreased with the approval of the Competent Authority".
- **M/S Arsalan Enterprises** is recommended as the lowest bidder for items at Sr. Nos. 2, 3, 4, 5, 6, and 7 (total of 24 tyres), with a combined recommended supply order amount of **PKR 2,347,000** (AS per CS at annexure A).

1. Review of Bids for Supply of Tyres

The Convener welcomed all participants to the meeting. The Goods Procurement Committee then convened to finalize the tender process for the supply of tyres for various university vehicles. The procurement was conducted under the single stage one envelope procedure, in accordance with KPPRA rules.

Two (2) bids were received in response to the tender notice. The bids were publicly opened in the presence of the participating bidders (M/S Arsalan Enterprises and M/S Sunshine Enterprises) on the specified date and time. A detailed comparative statement, summarizing the received bids, was presented for evaluation.
