**"The F&PC recommended following policy:**

#### **"REGISTRATION TRANSFER POLICY"**

- 1) In case of transfer of registration from an affiliated college/University Main campus to another affiliated college of the University, the applicant shall obtain No Objection Certificate from both parent college and host college.
- 2) In case an applicant desires to transfer Registration from an affiliated college to Main campus University of Swat, shall have at least 3.0 CGPA and NOC from affiliated college and university's concerned department.
- 3) The Registration Transfer cases will be submitted for initial scrutiny to the Director Admission office. Controller of Examinations will verify the applicant status and the same will be submitted for approval to the Hon. Vice Chancellor.
- 4) University of Swat shall charge Rs.5000/- per applicant as Registration Transfer fee."
