NOTIFICATION

Subject: REQUEST FOR RELAXATION IN UPPER AGE LIMIT FOR VARIOUS POSITION DULY ADVERTISED BY THE UNIVERISTY OF SWAT

It is notified for the information of all concerned that the Syndicate, in its 68th meeting held on April 25, 2026, vide item No. 04, considered the requests of applicants who had applied for relaxation in upper age limit in response to Advertisement No. 01-2026 and Advertisement No. 02-2026, and acceded to such requests by granting relaxation in upper age limit up to five (05) years under Rule 3 (3.1) of the University of Swat Rules for Age Relaxation in the Upper Age Limit for Recruitment, 2022, subject to fulfillment of all other eligibility criteria. The same shall also apply to similar cases, if any, arising upon completion of the scrutiny process within the said advertisements.

Candidates desirous of age relaxation beyond the jurisdiction of the Syndicate, i.e. more than five (05) years, may submit their requests to the Hon'ble Chancellor through University of Swat for onward forwarding through the Administrative Department for consideration.

The Syndicate further decided that, henceforth, cases relating to relaxation in upper age limit shall ordinarily be submitted for consideration only after recommendations for appointment have been made by the relevant authority in respect of the recommended candidate(s).

Moreover, the Syndicate directed that, in future, the condition relating to age relaxation may be omitted from the initial eligibility scrutiny criteria, and no candidate shall be declared ineligible solely on the basis of age prior to interview/consideration by the relevant authority, subject to final decision of the competent forum regarding age relaxation.

This notification is issued in implementation of the aforesaid decision of the Syndicate.
